The undersigned has contacted and conferred with counsel for Respondent Iowa Utilities Board and counsel for the Office of Consumer Advocate and proposed a 7-day extension to Petitioner's initial brief deadline with the remaining briefing schedule unchanged. There is no objection to this proposal.
- 7. Enterprise Products Operating, LLC hereby proposes the following amended schedule:
