PETITIONER SWAN LAKE ROAD FARMS, LLC'S NOTICE OF TRESPASS AND REQUEST FOR SUPPLEMENTAL HEARING

COMES NOW, Petitioner Swan Lake Road Farms, LLC, by and through the undersigned counsel, and states:

- 1. Within the last week, Swan Lake Road Farms, LLC ("SLRF") has learned that SLRF's contractor Terracon has commenced work related to the franchise in question.
- 2. Johnson County has confirmed that ITCM had not obtained a permit, as required, to commence construction in the right of way. Specifically, the Johnson County wrote on April 30, 2025:

Secondary roads confirmed there are no new permits along Swan Lake Road, but an ITCM sub is working within the railroad right of way in the general vicinity and got a permit Monday for spillover into the county's right of way.

We are unaware of any drilling along Swan Lake. If it is happening, it may be on private land not in the county right of way.

If your clients have observed drilling in areas that would require a permit, please have them contact secondary roads directly to report it.

3. Terracon, however, has trespassed onto SLRF's property beyond any

purported right of way and/or railroad easement. Tire marks in SLRF's crop field

confirms the trespass.

4. In light of ITCM's trespass onto SLRF property during the pendency of this

judicial review, it is clear that ITCM continues to ignore SLRF's property rights and is

likely that ITCM will cause irreparable and repeated harms to SLRF if no stay is issued.

5. SLRF requests a supplemental hearing on the matter of the requested stay

in light of ITCM's work without a county permit and in light of ITCM's trespass onto

SLRF's property.

WHEREFORE, Swan Lake Road Farms, LLC requests a supplemental hearing on

the matter of the requested stay and for all other relief deemed just and proper.
